



- I, _____, hereby agree to and understand the following statements.
1. I certify that my dog, _____, is in good health and has not, to the best of my knowledge, been in contact with any communicable illness within the past 14 days prior to attending and while at daycare.
 2. I understand that in order to determine if daycare is appropriate for my dog Ruffin' It Doggie Daycare has relied upon my representation that my dog has not injured or shown aggression towards any person or dog in the past.
 3. I understand that even though Ruffin' It Doggie Daycare is doing everything possible to provide a safe play environment for dogs and that nicks and scratches are common during normal play between dogs and agree that these risks are outweighed by the benefits associated with group socialization of dogs. I also understand that any minor cuts will be treated appropriately by the staff at Ruffin' It Doggie Daycare and pointed out to me upon pick-up.
 4. I understand that Ruffin' It Doggie Daycare will not be liable financially or otherwise, for injuries to my dog, me or any property of mine while my dog is participating in services provided by Ruffin' It Doggie Daycare. I hereby release Ruffin' It Doggie Daycare of any liability of any kind arising from my dog's participation in any services provided by Ruffin' It Doggie Daycare.
 5. I understand that I am solely responsible for any harm caused by my dog while my dog is participating in daycare at Ruffin' It Doggie Daycare. I hereby release Ruffin' It Doggie Daycare of any liability of any kind arising from my dog attending and participating in daycare.
 6. I further understand that Ruffin' It Doggie Daycare is following strict precautions during daycare hours for the safety of all the animals attending daycare. As a result I agree that any problems with my dog, behavioral, medical or otherwise will be treated and deemed by Ruffin' It Doggie Daycare in their sole discretion, and in the best interest of my pet. I understand and assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog.
